Fluorescent Safety Vest Policy

Safety Vest is not required at Small Loads Area.

Safety Vest is required in the Cell By All Unloading at the Working Face.

Safety Vest is required by All Commercial Haulers that also use the Yard Waste Area.

Home owners that use our facility are not required to wear vest at Small Loads Area or the Yard Waste Area.

Commercial Vehicles

Commercial Vehicles must have the correct Company Name and a vehicle number attached to both sides of the vehicle which is visible to the scale house operator. All containers (tubs/trailers) must have a number attached to both sides of the container (tub/trailer) which is visible to the scale house operator.

NOTICE: ALL LOADS, including yard waste, brought to the Black Hawk County Sanitary Landfill shall be tarped 100%, and be fully secured in all areas or additional fees will apply. This shall be required at the load's point of origin and will include bulky materials and yard waste. State Law requires all vehicles carrying materials on public right-of-ways to be covered with a tarp or otherwise secured: (IOWA STATE 321.460)

Additional Fees:

Small Non-commercial Uncovered loads - \$5.00/\$20.00

Large Non-commercial Uncovered loads -\$20.00/\$30.00

All Commercial Uncovered loads -\$20.00/\$30.00

**Fluorescent Bulb Surcharge \$5.00 each (Commercial Business TCLP test required)
Appliances (including light fixtures) deposited at the working face - \$35.00 each
Commercial Appliances at the working face – Please call Landfill**

Yard waste mixed with other waste - \$80.00 per ton

Extra Fees for tires deposited with waste and or at the working face – please call landfill

No hazardous materials accepted as defined by the Iowa Department of Natural Resources and Environmental Protection Agency

**ALL DOORS MUST BE CLOSED BEFORE ENTERING ANY ACCESS ROAD
OUTSIDE THE CELL**

This is a reminder to all haulers concerning the complete and total tarping of the openings on compactor boxes; and the closure of all doors on packer trucks; and the complete tarping of all other loads coming in to the Black Hawk County Landfill.

The openings on compactor boxes must be completely tarped with a one piece tarp or diaper that is secured to stay in place and shall not be untarped until inside the active cell litter fence containment. As of late several haulers have been using unacceptable pieces of cardboard, diapers or tarps which are too small, or bungees only.

Also, packer trucks shall close all doors to secure the load as they travel to the landfill and remain closed until they are inside the active cell litter fence containment.

Also, all other type loads and containers must be tarped 100% and secured completely and remain that way until they are inside of the active cell litter fence containment.

If these Landfill Rules & Regulations are not followed the landfill personal will assess a \$20 uncovered load charge to any load not abiding by these rules & regulations. There will be no exceptions.

It is your responsibility to inform your drivers, and the Driver's responsibility to abide by ALL the Landfill Rules & Regulations.

State Law requires all vehicles carrying materials on public right-of -ways to be covered with a tarp or otherwise secured: (STATE OF IOWA CODE 321.460)
