Household Hazardous Materials

Accepted for Free Disposal

Home & Garden

Household cleaners, removers, floor care products, etc.
Mercury (including switches & thermometers)
LED & fluorescent bulbs (compact & tube) - **No fixtures**
Fluorescent ballasts - **Must be removed from fixtures**
Liquid fertilizers, herbicides, pesticides, & poisons
Clogged aerosol cans (including aerosol spray paint)
Rechargeable & button batteries (*** No Alkaline**)
Rust removers & metal polish (solvent-based)
Polish remover & rubbing alcohol
Pool chemicals



Garage & Workshop

Propane tanks
Gasoline, kerosene, lighter fluid, etc. (Please notify the unloading volunteers if you need your gas can back)
Varnish, shellac, stain, & mineral spirits/thinners
Driveway sealer, concrete cleaner, & etches
Auto starter fluid, brake fluid, & carburetor cleaner
Lead-acid batteries (car, truck, mower, motorcycle, etc.)
Auto polish & car wax
Adhesives, epoxy, & glues
Roofing tar
Acids/bases

**NO containers
larger than 5 gallons
(no drums)**



Electronics & Electric Devices

Accepted for Recycling (Fees May Apply)

Two CRT devices per vehicle at no charge:
(\$5 for each additional CRT)**

CRT = Non-flat panel computer monitors AND televisions

(including console, projection, etc.)

**** Exact cash only. Will NOT accept bills larger than \$20**



No charge items include:

Flat panel computer monitors & televisions

Computer equipment, laptops, computer towers, keyboards, routers, mice, cords, desktop fax/copiers, printers, ink cartridges, & hard drives (hard drives will be shredded after the event)

Handheld electronics, phones, mp3 players, etc.

Audio-visual equipment, DVD/VCR players, game systems, radios, stereos, cassette, & record players

Countertop kitchen gadgets, toasters, blenders, mixers, can openers, toaster ovens, etc.

Electric items, vacuums, fans, humidifiers, holiday lights, tabletop/floor lamps, treadmills, curling irons, hair dryers, electric keyboards, electric space heaters, power tools & batteries, sump pumps, garage door openers (NO chains or tracks), electric air compressors, electric power chairs, cable & satellite equipment (NO poles or cement), etc.

Not Accepted during this Commission Subsidized Drop-off Event



Non-hazardous garbage items, such as:

- **Tires, appliances (including microwaves, dehumidifiers, air conditioners, water heaters, etc.), and bulky items (couches, mattresses, carpet, etc.)** - Contact your city waste department, the Cedar Falls Transfer Station, or the Black Hawk County Sanitary Landfill.
- *** Alkaline batteries (single use AA, AAA, D, 9 volt, etc.)** - Throw away (per the IA DNR).
- **Paint** - Thoroughly dry & throw away (leave lid off can).
- **Laundry detergents, soaps, & cosmetics** - Thoroughly dry liquids & throw away.
- **Lawn mowers, weed eaters, & gas/charcoal grills** - Contact your city, the landfill, or a scrap metal company.



Other materials, including:

- **Medications and medical sharps** - Contact your pharmacy/physician; take to approved location.
- **Asbestos** - Contact the Black Hawk County Sanitary Landfill.
- **Motor oil, oil filters, & antifreeze** - Contact your local service station, auto dealer/auto parts store, or the Cedar Falls Transfer Station (motor oil and filters only).
- **Ammunition** - Contact the Black Hawk County Sheriff's Office or your local police department.
- **Fire extinguishers** - Contact the Waterloo Hazmat Center or a local scrap metal company for instructions.
- **Smoke alarms & smoke detectors** - Contact the manufacturer for mail back instructions (per IA DNR).

No items from businesses, schools, farms, churches, non-profits, or governmental entities.
